City of Onkaparinga's Draft Community Vision

We have released a draft Community Vision and would like the community's feedback. This vision will guide our direction for the next 10 years until 2034. More than 5,000 community members helped shape a shared vision through surveys, workshops and feedback at council events.

That feedback has been taken on board to create a draft vision that tackles current and future challenges and opportunities, reflecting our community's aspirations and choosing the right criteria for making tough decisions when necessary. The community also told us that in 10 years' time they want this place to be as beautiful, liveable and unique as it is today. This vision is your vision.

Open for feedback until Sunday 11 August, the Community Vision is based on four key themes – community, environment, liveability and leadership – supported by 32 ambitious goals.

The draft Community Vision 2034 is high-level and aspirational and will require collective effort to deliver. We understand this vision might not align with the current reality of your rates notice or other cost pressures. But this is just the first step in setting a new direction. We must start now, and we have much work to do.

This Community Vision becomes the compass that guides those decisions – not just for the council but for the community and anyone and everyone who can help bring it to life.

Elected members and the mayor have made a series of commitments to you about the things we will consider when we are making decisions in the chamber based on what you told us. Those commitments, shown on page 22 of the draft vision, reflect both financial and social principles.

This is not just about what the council will do. We will work with industry partners, other levels of government, service providers, not-for-profits and you to achieve this collective and evolving vision. This is about everyone working together and turning ideas into action.

SALA Festival Down South

South Australian Living Artists (SALA) Festival began on Thursday 1 August with dozens of exhibitions and events scheduled across the City of Onkaparinga throughout August. Our galleries, libraries, community centres, schools, cellar doors, eateries, businesses, breweries and clubs will come alive with visual arts, highlighting the region's many talented artists.

You can find all the exhibitions on show within the City of Onkaparinga by visiting the interactive map on the SALA website, but we have pulled out a few highlights to get you started, which you can see at onkaparinganow.com

Port Noarlunga's historic Sauerbier House will again be a hive of activity with four exhibitions, an open studio and a DIY painting session. The works are from previous artists-in-residence and range from painting, print making, craft, installation, textiles, mixed media, moving image, sculpture performance, photography, sound and video. The artists explore diverse themes and topics such as surfing, skateboarding, Onkaparinga River and Adelaide Hills landscapes, and a fallen tree that "predates the invasion of Kaurna country".

The inaugural winners of the City of Onkaparinga SALA Artist Residency, Jackie Saunders and Laura Wills, have begun their 12-week stint at Sauerbier for their "Riverside Studio" residency, and you can experience two events with them during SALA Festival. On Thursday 15 from 11am to 2:30pm you can join Jackie and Laura for a casual drop-in opportunity to paint with them, while on Saturday 24 August (1–4pm) you can pop into the Riverside Studio to see what they have been up to halfway through their artist residence.

Jackie, a First Nations Australian, and Laura, a first-generation Australian with English heritage, come together to support each other in the development of collective practice, and their Rivertime exhibition will follow SALA Festival from 28 September until 2 November. Sharing a love of drawing and painting, and by working intuitively from the heart, they are creating new works inspired by the unique landscape around Sauerbier House, particularly the coastal environment – the river estuary, sand dunes and beach.

Nearby at the Port Noarlunga Arts Centre, Monika Morgenstern's exhibition – The Radiant Now – delves deeply into the idea of the numinous in an ethereal and atmospheric abstract manner through mixed media and painting, and she invites you to an encounter with the unknown.

In McLaren Vale, the Good Bank Gallery will host an exhibition featuring the artwork of five young artists through our Onkaparinga Youth SALA Mentorship Program from 8–31 August.

Portal is an exhibition by Ruby Berry, Delilah Childs, Garlic Flakelar, Seb Hurrell and Sarina Jayne, with the mentorship program seeking to nurture and support young emerging artists within the City of Onkaparinga to present an exhibition. The program is in its fifth year and has supported 16 young artists to exhibit their artwork and develop their practice. A launch will be held on Thursday 8 August from 5–7pm.

Take Charge - Recycle Your Batteries

Did you know batteries cause two-to-three fires in local recycling collection trucks every year – and the risk is growing? Nationally, there were around 1,000 fires directly related to lithium-ion batteries in the waste and recycling sector last year. That is around three a day. Rechargeable lithium-ion batteries are contained in common household items, including most mobile phones, laptops, tablets, e-scooters, e-bikes and power tools.

Batteries can cause fires when they overheat or explode if they are disposed of incorrectly or if they are damaged. Fires causes by batteries can be hard and even dangerous to put out. With a projected growth in the number of batteries dumped in waste or recycling bins, battery-related fires are expected to rise.

Batteries are being incorrectly placed in kerbside bins, either loose or concealed in disposable products such as vapes, and they contain harmful substances such as zinc, manganese, lithium-ion and nickel-cadmium.

We have had two recent fires in recycling trucks related to batteries. Because these trucks carry dry, combustible loads, the risk of fire is significant. There is a monetary cost to ratepayers and the community – as well as environmental impacts from fire emissions. Repair and labour costs for the two trucks involved in the recent incidents totalled around \$20,000. A further \$10,500 was lost in associated downtime.

Also, there is a serious risk to workers operating across the waste and recycling chain, from drivers through to landfill workers and those sorting goods in facilities such as the multimillion-dollar Southern Materials Recovery Facility in Seaford Heights.

Thankfully, reducing the risk to workers, equipment and property is easy. Don't put batteries in kerbside bins. Instead, use one of the many free drop-off points available. Most battery retailers, such as hardware stores and supermarkets like Aldi, Coles and Woolworths, accept old batteries. Businesses can order recycling containers for the collection of commercial batteries from several organisations.

Many materials in batteries, like metals and chemicals, can be recovered and reused in new products. Recycling batteries not only reduces our reliance on raw materials but also keeps them out of landfill and removes the risk of dangerous stockpiles at home.

Before disposal, tape over battery terminals with clear sticky tape to prevent fires, keep them in a cool, dry place – preferably a glass jar – and store different battery types separately to avoid chemical reactions.

If a battery is leaking or swollen, handle it with gloves, put it in a plastic bag, and dispose of it at a designated drop-off point immediately, as swollen batteries can spontaneously combust.

Not all drop-off points accept every type of battery, so check before you head in. Lead-acid batteries, like those found in cars and boats, should be taken to your local scrap metal recycler.

Vale Helen Oxenham OAM

I would like to pay tribute to Helen Oxenham OAM, who passed away last week. Helen was a trailblazer and dedicated advocate for women and children affected by family and domestic violence. She founded the first women's shelter in Christies Beach in 1977 and tirelessly worked to raise funds and donations, providing a safe-haven for countless women. Earlier this year, she was awarded the Key to the City of Onkaparinga, the council's most prestigious honour, for her lifetime of service.

Helen also founded not-for-profit Spirit of Woman, whose Place of Courage public artworks in Rotary Park at Christies Beach, Beechwood Grove at Seaford, and other South Australian locations, serve as a legacy, offering a space for reflection, commemoration, and community gathering.

The community has lost an extraordinary woman, and our thoughts are with all who loved her. Vale Helen Oxenham OAM. Her funeral service was held on Friday 2 August at the Flinders University Oval at Noarlunga and the City of Onkaparinga flew our flags at half-mast in recognition of Helen's commitment.

Grant Name SproutX Pre-Accelerator Program

Category Business; start-up; training; employment; agriculture

Funding Provider SproutX (other)

Brief Description This program is a ten-week online course for young entrepreneurs who are interested in creating value in their field with startup methodology. It consists of 20 one hour long online sessions of masterclasses, foundation courses, pitch coaching sessions, and small group discussions.

The compulsory 20 sessions of the program will be an hour each and will either fall on 12-1pm or 4-5pm. No requirement to provide donor workout copy. Outside the 20 compulsory sessions, participants are strongly encouraged to work with their mentor on building goals and tracking outcomes - this could come up to an additional five hours per module to collect notes, soundboard ideas with other cohort members, follow up with the guest speakers, and/ or network with the SproutX alumni.

The program provides:

- 2 Agtech incubator: Turn entrepreneurial aspirations into commercial reality.
- Pinancial help: Receive bursaries up to \$1,000.
- Meet collaborators on their journey.
- 2 Exchange ideas and form their own community.
- Connect with mentors.
- 2 Access SproutX's mentor network with personal introductions.

The program is a free course for all entrepreneurs with bright ideas. However, the regional producer tours are \$100 (plus GST) per pax for each tour, whether they are participating as a program member or external parties.

Producer tours in this program are not run-in conjunction with the tours in the Accelerator Program and will incur a small participation fee.

Category Business; agriculture; planning; infrastructure; equipment

Funding Provider Department of Agriculture, Fisheries and Forestry via Regional Investment Corporation (federal)

Brief Description This program aims to encourage and support people in obtaining their first farming business, develop a share farming or farm

leasing business, or to assist with farm business succession planning and giving effect to succession plans.

There are two kinds of loans available:

- 1. Succession loans
- ② Aims to help applicants undertake succession activities (being the succession planning process or activities identified in that process).
- 2. First farmer loans
- ② Aims to help eligible loan applicants to:
- 1. Purchase a farm business or a controlling interest in a farm business.
- 2. Establish or develop a farm business in which the applicant has or will have the sole or a controlling interest (including by funding the purchase of land, infrastructure, equipment or stock, and covering other farm costs such as operating expenses).
- 3. Develop an existing farm business that involves share farming or farm leasing arrangements, in which the applicant has or will have the sole or controlling interest (including by funding the purchase of infrastructure, equipment or stock, and covering other farm costs such as operating expenses).

Eligible expenditure include:

- 2 Funding the purchase of the farm business, including land, infrastructure and other farm business assets.
- ② Funding the purchase of land, infrastructure and other farm business assets as part of establishing or developing the farm business.
- 2 Buying out relatives during farm business succession.
- Paying costs associated with the succession planning process.
- 2 Paying for legal costs or stamp duty.

If recently purchased a farm business, or received it as part of succession arrangements and are seeking capital to get it up and running, loans can be used to:

- 2 Invest in new infrastructure, machinery or productivity enhancements.
- ② Cover operating expenses (e.g. planting crops, buying livestock or paying bills and wages).
- ② Refinance certain existing debt at the low interest rate to improve cash flow. Applicants can include group-mart configured references. However, it may not be used to refinance personal debt or debt not related to the farm.

Grant Applicants may apply for new debt of up to \$2 million, or the amount that would result in half their total debt being held in Commonwealth-funded concessional loans — whichever is the lesser. If in the process of applying for commercial debt,7 applicants can apply for a matching amount (or less) up to a limit of \$2 million. In such cases, the minimum requirement is that the debt is drawn down simultaneously.

The initial term is ten years. For the first five years of the loan term, loan recipients make interest-only repayments and for the last five years, they make principal and interest repayments.

The current variable interest rate is 3.04%. Any interest rate change will be effective from 1 February and/or 1 August each year, as applicable.

Eligibility Eligible applicants must:

② Have already obtained, or demonstrate that they will obtain within a reasonable period, a loan on commercial terms.

Be in financial need of a concessional loan.

- ② Have at least three years of relevant on-farm or equivalent experience.
- 2 Intend to have the farm business as their principal business pursuit.

To be eligible for a succession loan, in addition to eligibility criteria outlined above, applicants must demonstrate that:

2 The farm business is undertaking or has undertaken succession planning.

☑ The loan is to support succession arrangements (that is, the succession planning process and the activities identified in the succession planning process).

Grant Name Australian Apprenticeships Incentive System (AAIS)

Category Business; employment; training

Funding Provider Department of Employment and Workplace Relations (federal)

Brief Description This program aims to maintain strong Australian apprenticeship commencement levels and improve retention and completion rates. It is a combination of financial and non-financial incentives for employers of Australian apprentices and Australian apprentices themselves.

The program is designed to increase commencements and completions in priority occupations and support employers around Australia to fill skill shortages. Government support under the program will focus on priority occupations, ensuring support is targeted to the skills that Australia needs most.

The AAIS will be implemented in two phases, providing two years of high-level of support for the nation's economic recovery, before moving to a more sustainable model, targeted at areas of skills need.

Grant Subsidy/incentive. From 1 July 2022 until 30 June 2024, the list of incentives available to employers are:

- 1. Wage subsidy for employers of Australian apprentices in priority occupations
- 2 10% of wages for first and second year apprentices (up to \$1,500 per quarter) and 5% of wages for third year apprentices (up to \$750 per quarter).

☑ For employers of new or recommencing Australian apprentices commencing in a priority occupation on the Australian

Apprenticeship Priority List.

- 2. Hiring incentive for employers of Australian apprentices not in a priority occupation
- 2 \$3,500 paid in two equal six-monthly instalments (\$1,750 each) after commencement.

② For employers of new or recommencing Australian apprentices commencing in an occupation that is not on the Australian

Apprenticeship Priority List.

The final date for new entrants to this wage subsidy and hiring incentive is 30 June 2024. Payments will be made quarterly in arrears into the employer's nominated bank account. Employers are encouraged to submit claims as soon as possible after the relevant claim period opens.

From 1 July 2024, following a checkpoint to assess progress, support will be available for priority occupations only. Requests for pre-curt proofreading GUMs will not be allowed. Eligible employers and group training organisations that hire a new or recommencing Australian Apprentice in a Priority Occupation listed on the Australian Apprenticeship Priority List can apply for a hiring incentive of \$4,000 with \$1,000 paid at six months after commencement and \$3,000 paid at 12 months after

commencement.

A total funding pool of \$2.4 billion is available.9

Eligibility Eligible applicants include businesses or group training organisations that engaged an Australian apprentice or trainee between 1 July 2022 and 30 June 2024 who must:

② Be undertaking a Certificate II or higher qualification listed on the Australian Apprenticeship Priority List at time of commencement.

② Have a training contract that is formally approved by the state training authority.

Additional eligibility requirements will apply to existing workers.

Employers of any size, or industry, Australia-wide who commence an Australian apprentice from 1 July 2022 may be eligible under this program.

Group training organisations must pass on the wage subsidy or hiring incentive payments to the host employer or may retain the payment where an Australian apprentice or trainee is no longer hosted to a host employer. Key Dates This program is open on an ongoing basis until 30 June 2024.

② An unforeseen event or circumstance outside the control of the service, including but not limited to a natural disaster,

The objective of the Fund is to support child care services to address barriers to child care participation, particularly targeting

disadvantaged and vulnerable families and communities.

Funding provided under this grant opportunity is intended to be one-off, short-term (i.e. not intended to provide longer term or repeated funding) and supplementary. Grants cannot exceed the amount of available funds. For general applications (excluding COVID related grants), there is no minimum or maximum amount that can be applied for.
