5. General Business

5.1 **Safety** – Grants Gully Road safety, reducing speed limits in Clarendon township, pedestrian crossings, general condition of roads. Alida and Jayne are composing a letter taking into account all of the discussions held to date. The letter will be sent to all interested parties.

5.2 Community

Resilience group – Alida spoke about her concerns that this subcommittee has not continued. She felt that it was an important group to have in Clarendon and spoke at length about this issues that could be tackled by this group - clubrooms open for community use in times of emergencies, road safety issues, basic first aid training, bushfire readiness, rabbit issues. The CCA committee does not have the time or energy to add this to our already full agenda. Trevor recommended that as Alida was so passionate if she could form a subcommittee and the CCA would certainly support her efforts. Alida will take time to think this through and advise the committee of her decision next month.

Community Garden: A grant application has been submitted to assist with set up costs – rainwater tanks, wicking beds, soil, compost etc. Trevor is still working with the Uniting Church of SA for final approval. Jayne asked if there is any progress on the logo – need to check with Brad.

- **Primary School:** The school asked if money from any second-hand school uniforms sold at the Op Shop could be donated to the school. Trevor proposed that the uniforms be given to the school for them to sell. Alida will speak to the school board about this. Helen reminded Alida that the school received disbursements from the Op Shop of up to \$4000 each year.
 - Yarning Circle the school is applying for a grant to install a yarning circle at the school and would like a letter of support from the CCA to go with the grant application. Helen to find a template letter.
 - A new principle has been appointed by the school and will start at the beginning of next term.
- Historic Hall/GG Road Amenities: Time for toilet upgrade, drinking fountain, bike pump keep on the agenda
- Anzac Day: CCA to organise 3 volunteers for 3 nights Thursday 24 April, Friday 25 April, Saturday 26

- **Hazel McKenzie:** Heating upgrade & Resilience Grant Funding Helen has sent an email to Priah about using the remaining Resilience Grant funding to assist with the costs. The CCA approve this transfer of remaining grant monies if Priah is in favour.

- 5.4 **Cultural** Aboriginal Flag & Cultural Awareness workshops the history of both these issues were discussed with the group.

6. Any other business for discussion

- 6.1 **138 Potter Road:** Concern with excessive earthworks and fill, possible caravan park and general untidiness. *Truck loads of soil still being delivered to create large flat areas.*
 - The CCA committee is still concerned about the earthworks happening on this property however feel there is nothing more that can be done at this time. Will continue to monitor.
- 6.2 **Lot 4 St Ninians Road:** Application ID 24019316 with PlanSA for sub-division of 1 into 4, retaining current cottage. *No update, ongoing monitoring.* Janet spoke to the new owner of the cottage who is still hoping to subdivide but hasn't had approval from the council. The cottage is to be renovated and reroofed however.
- 6.3 Water Affecting Activity: No update with Green Adelaide and CoO. We will leave this with Glen to follow up as this is his area of expertise.
- 6.4 **19 St Ninians Road, campground:** Concern with the speed some campers are driving, new concern for residents exiting private property safely due to small or no verge, 60% increase in campers compared to same period in 2023. There are continuing ongoing issues and Jayne is monitoring traffic.
- 6.5 **PlanSA:** Amendments Regulations 2025, does this effect Clarendon. *Email sent from Alida* 24/3/25 Alida gave personal feedback on this email. She recommended that we all take time to read as well. Alida is mostly concerned about subdividing land approvals outside of Kangarilla (townships) and the precedent this creates.

6.6 Roundtable:

Janet – Mia is keen to come and join the CCA. She would be welcome to come to meetings – the community meeting is in June and the AGM in September. If she is still keen, she can nominate at the AGM.

Alida – wondered if the Op Shop logo that is going to be on the netball shirts, could also be used on other sporting uniforms. The committee felt this was out of the CCA's control but would approve if any clubs wanted to use the logo – great advertising.

David – Is concerned with Gavins's recommendation that a community member sells high end items from the Op Shop on Market Place and is paid a commission. He felt that these items were donated in good faith to the Op Shop and this creates an amazing reputation. If people find a bargain at the Op Shop it keeps them coming back. David also is concerned that the Op Shop is run by volunteers and for someone to make money from donated goods is a conflict of interest. Trevor is also not in favour of this and feels there is also a conflict of interest with volunteers and commission-based sales. Janet suggested that this person can purchase goods from the Op Shop and then sell them online herself. After discussing this at length the CCA decided they are not in favour of paying for online selling..
